Board Minutes

PVOA Board of Directors Meeting Unapproved August 14, 2024

Vice President Patrick Dodge called the meeting to order at 7 PM. Board members in attendance: Patrick Dodge, Randy Warm, Mike Wright, Devin Peterson and Mike Roggenbuck. Absent: Ashley Druhl, Holly Lischer and Sean Stoube. Also in attendance: Ben Petty, maintenance; Gary Culver, maintenance; Deanna Nielsen, clerk; and Lindsay Westfall, clerk.

Mike Wright made a motion to approve the July minutes. Randy seconded. All in favor, motion carried.

Devin made a motion to approve the July treasurer's report. Randy seconded. All in favor, motion carried.

OPEN TO THE FLOOR:

COMMITTEE REPORTS:

Legal: Due to Ashley's resignation, filing of the claim to continue covenants was not completed. Deanna states claim in 2008 extended covenants through 2028. Patrick will contact the lawyer to confirm or get claim filed if necessary.

Insurance/Public Relations: Due to Holly's resignation, we will need to contact to get insurance file returned to office. Trees discussed in July meeting have been looked at, are live trees and currently not a danger, not time sensitive. Potentially reviewed again in 2025.

County Liaison: A report of a baking dog from June still could not be followed up, as the caller did not leave their name. Multiple attempts have been made. A request to contact county regarding potholes on Park Avenue S. A complaint regarding watershed project was discussed, resident was referred to the water company as PVOA does not take over maintenance for another year.

Park Board: Quad City Fall Ball starts August 24th, after that ends everything

will be winterized.

Architectural Control: Mike R. reviewed and approved one shed application. A resident with an approved garage application requested a change in size/dimensions, however the new dimensions do not require a new application as it is under 120 square feet. Resident advised to contact county for any necessary permits.

Maintenance Control: Air conditioning and starter were both replaced on tractor. Took down the south entrance signs and repaired. We will keep the letters and numbers for signs with board members only. Mowing has been caught up since tractor has been repaired. Spraying done at Dexter. Ben took care of a hornet's nest that was posted on Facebook.

Office Activities: Financial records for July were reviewed by Randy & Devin will also review. Devin & Mike R. will review August records.

Parkway Development: No report.

Mediacom: Received a check in the amount of \$1426.21 for 2nd quarter franchise fee.

OLD BUSINESS:

Siren Maintenance: Deanna called LMI, stated they would have someone come out for scheduled maintenance.

Hiring new office clerk: Lindsay Westfall was hired as new office clerk and started on August 5th. Discussed an employment agreement to protect both the PVOA and new employees. Deanna created and was signed by both Patrick and Lindsay.

Wage adjustment: Was approved previously for Deanna however no final decision was made for other employees. Back pay for new approved wage to be paid. \$1 per hour for maintenance positions.

Monthly meetings are held the 2nd Wednesday of the month at 7 pm the PVOA Office Building, 17 Lincoln Ave. All residents are welcome to attend.

Patrick motioned to make that adjustment back dated to August 5th, Randy seconded. All in favor. Motion carried.

Tour for board members of PVOA land: Discussed taking the board members to look at PVOA land. Ben to conduct tour of PVOA land Tuesday, August 27th at 6pm.

Resignation: Two board member resignation requests were received by Holly Lischer and Ashley Druhl. Mike R. moved to accept the resignations immediately. Mike W. seconded. Motion carried.

Announcements: Need volunteers to join the board. A

resident sent an email with a picture of a shed asking if it would be allowed, however the shed is a temporary building and would not be approved due to the inability to withstand weather/wind.

Patrick made a motion to adjourn. Devin seconded. Meeting adjourned at 7:55 pm.
